Membership

Grants

RAW recently submitted an application to Bank Australia to install a small solar system on a community organisation in Albury and start a revolving fund where we can obtain 'solar panel sponsorship' and keep funding new systems on other community buildings. If successful, the grant will help fund the first installation.

Wodonga Community Solar Project

Update from Ben McGowan

Wodonga Council has received a Climate Change Innovation Grant from the Victorian Government for the Wodonga Community Solar project, and RAW Energy is the key delivery partner for this grant. The project responds to climate change by implementing a working example of a community renewable energy model, which provides ongoing funding to support an Energy Benefits Program (EBP). The EBP's objective is to support those experiencing energy poverty in the Wodonga local government area.

The Community Renewable Energy Model

The Project Control Group, comprised of RAW volunteers and Wodonga Council staff, has looked at many different possible options for a community renewable energy model over the last six months. The model that has been selected pursues opportunities to supply large electricity users with solar power, through community owned rooftop solar power systems. Under this model, RAW has been working with Wodonga Council, and distributed energy specialists Mondo. RAW has approached businesses in the Moloney Dr industrial estate, offering them on site renewable energy, at a competitive tariff. The price of this electricity can be as much as three times cheaper than electricity purchased from an electricity

retailer. Included in the price of this electricity cost will be a small amount that contributes to the Energy Benefits Program.

RAW is now working with Mondo to prepare final offers for interested businesses. A community investment model will be used to fund and then own one of these rooftop solar power systems. The next stage of this project is to determine how best to coordinate this investment opportunity.

The Energy Benefits Program

RAW was successful in a further grant application to the Victorian Government's Renewable Communities program. This grant is helping to fund a pilot study that will inform the full Energy Benefits Program. RAW has partnered with social housing service provider BeyondHousing to deliver the program. RAW will install ten solar power systems on BeyondHousing houses and carefully measure the impact for social housing clients, on their electricity bills and household budgets. This program seeks to ensure that the benefits of renewable energy are available to all, and it is hoped that demonstrating these benefits to BeyondHousing will help them work towards renewable energy solutions for their entire housing stock. Installation of the ten solar power systems is expected to occur in April.



How it works

Businesses participate in the Energy Benefits Program by hosting a solar power system and agreeing to purchase low cost renewable electricity for a dedicated time period. There are no upfront costs and the price of the renewable electricity purchased from the onsite system is

typically more competitive than commercial retail rates. Included in the cost of the electricity is a small levy to fund the Energy Benefits Program. In the mid-term, businesses will receive further benefit through energy sharing across the hub. Indigo Power

Community owned solar for Old Beechworth Gaol

The North East is a step closer to its hundred-percent renewable energy goal, with the launch of the region's first community-owned solar power system. On April 12th, Indigo Power switched on its first community owned solar system, which will supply low cost, renewable energy to the Old Beechworth Gaol site. The panels at the Old Beechworth Gaol allow businesses to access the energy without buying the infrastructure.

Indigo Power Retail

Indigo Power is working towards a launch of its retail offering. We are planning to go live in May 2019 with a 'soft launch' in Yackandandah. Those within a 10 km radius of Yackandandah will be the first participants in our Indigo Power retail offering, with the soft launch focused on trialling our electricity sharing mechanism. A full launch of the retail offering across the Hume and Murray Regions will occur early in the new financial year. Indigo Power is planning a capital raise at this time, using equity crowdfunding to secure widespread community ownership.

What's to come?

Over the next few months, a new website will be launched where you will be able to sign up to be an Indigo Power customer. Indigo Power is also looking to partner with more local businesses for community owned rooftop solar installations

NSW update

The NSW Government is introducing interest free loans for battery or solar and battery installations. Details are not yet known although the loans will not be available for solar only installations. A commencement date is expected in the latter half of the year.

Victorian Rebate update

In the next financial year, we will see some new rebates launching in Victoria to accompany their solar power and hot water rebates. There will be the launch of a battery rebate of up to \$4838 plus the introduction of other changes. Solar companies will now be able to offer rebates as a point of sale discount. Customers will be required to use a Clean Energy Council Approved Solar Retailer in order to claim the rebates. For more information you can head over to <u>www.solar.vic.gov.au</u> website.
